### **Rating rationale:**

Coupon type

Object of this rating are the MEIF VI Notes (rating object) issued by Institutional Infrastructure Holdings S.A., Compartment 25 (borrower). The borrower invests the proceeds indirectly in the form of equity in infrastructure assets. The investments will be made through the Macquarie European Infrastructure Fund VI S.C.Sp. (investment vehicle). The relevant manager is Macquarie Infrastructure and Real Assets (Europe) Limited (MIRAEL).

CRA's assessment of the structural risk of the transaction is unchanged compared to the previous year, as no significant amendments were made within the transaction. Although the impact of COVID-19 is diminishing, new economic risks emerged at the beginning of 2022, so that the operational risk remains elevated. Since our last follow-up rating, the manager was able to close further investments and bring the portfolio to its final number of nine assets, which is at the lower end of the originally communicated plans. Thus, no blind pool risks were considered in CRA's quantitative analysis. Due to the investment vehicle's limited number of investments, diversification effects are used only to a limited extent. High idiosyncratic risks combined with a further material deterioration of the portfolio investments' credit qualities let to a revaluation of the portfolio and credit risk, which we now assess as elevated to high. CRA updated the input factors for our quantitative cash flow model with most recent information. The base case result is BB-, which is a deterioration by three notches compared to last year. Sensitivity analyses performed on several fluctuating input parameters confirmed a sub-investment grade status for the transaction under review. Consequently, an investment grade rating is not supported any longer by quantitative results, which is why CRA has downgraded the rating from BBB-/stable to BB/negative. We downgraded the rating by only two notches, as the current fund performance is above our base case assumption and we see no immediate liquidity shortfall risk on the borrower level, as all coupon payments are conditional. CRA set the outlook to negative due to elevated economic risks, which may have negative effects on fund's future performance as well as on portfolio investments' credit qualities.

### **Rating sensitivities:**

Best-case scenario: In this scenario, we stressed (ceteris paribus) the return and the average PD¹ of the portfolio assets by an amount of +1%-point and +1 notch respectively, resulting in a rating of BB.

Worst-case scenario: In this scenario, we stressed (ceteris paribus) the return and the return volatility of the portfolio assets by an amount of -1%-point and +14%-points respectively, resulting in a rating of B.

#### **ESG-Criteria:**

CRA generally considers ESG factors (environment, social and governance) within its rating decisions. In the present case, ESG criteria had no comprehensive impact to the rating.

Closing of the transaction occured on 26/10/2018. The rating is based on the portfolio information and transaction documentation as of 29/08/2022, as provided by Macquarie or the Issuer.
